<b>Safe Sleep Practices and SIDS Risk Reduction</b> <i>658E.c.2.1</i>			Provider follows the following safe sleep practices as recommended by the Centers for Disease Control and Prevention (CDC) and the National Institute of Child Health and Human Development (NICHD): a) Always place babies on their backs to sleep. b) Use a firm sleep surface, such as a mattress in a safety-approved crib, covered by a fitted sheet. c) Babies are not allowed to sleep in an adult bed, on a couch, or on a chair alone, with you, or with anyone else. d) Keep soft objects, such as pillows and loose bedding out of baby’s sleep area. e) Do not smoke around infants or any other child in your care. <i>CFOC-3.1.4.1</i>

<b>Medication and Training for Administration and Storage of Medication</b> <i>658E.c.2</i>			Prescription or non-prescription medication (over-the-counter) ordered by the prescribing health professional for a specific child with written permission of the parent/guardian. a) Written orders from the prescribing medical need, medication, dosage, and length of time to give medication. b) Labeled medications brought to the early care and education facility by the parent/guardian in the original container (with a label that includes the child's name; date filled; prescribing clinician's name; pharmacy name and phone number; dosage/instructions/relevant warning as well as specific, legible instructions for administrant; storage; and disposal). c) Medication has child-resistant caps; Kept in an organized fashion; stored away from food; stored at the proper temperature; completely inaccessible to children. d) Provider who administers medication completed a standardized training course that includes how to administer medication. <i>CFOC-3.6.3.1/3.6.3.2 CFOC-3.6.3.3</i>

<b>Smoke Detectors- Detectors Installed and Operational</b> <i>658E.c.2.K</i>			<ul style="list-style-type: none"> <li>a) Do not put detectors within six inches of where walls and ceilings meet, or near heating and cooling ducts. Air flow is restricted in these areas and alarms may not work properly.</li> <li>b) Put a detector in each sleeping room and place additional detector(s) in the hallway. Please note: detectors should be tested monthly and batteries replaced annually.</li> </ul>			
<b>Safety Covers and Shock Protection Devices for Electrical Outlets</b> <i>658E.c.2.K</i>			All accessible electrical outlets are “tamper-resistant electrical outlets” or “safety covers” that prevent children from sticking objects into receptacles. <i>CFOC-5.2.4.2</i>			
<b>Location of Electrical Devices near Water</b> <i>658E.c.2.K</i>			No electrical device or equipment accessible to children or plugged into an electrical outlet while a person is in contact with a water source, such as a sink, tub, shower area, water table, or swimming pool. <i>CFOC- 5.2.4.4</i>			
<b>Integrated Pest Management</b>			Provider has a practice for pest exclusion, sanitation and clutter control, and elimination of conditions that are conducive to pest infestations. <i>CFOC- 5.2.8.1</i>			
<b>Household Pets</b>			<p>A statement from a veterinarian that all household pets are up-to-date on required vaccinations.</p> <p>Litter boxes and pet food dishes must be kept out of the reach of children.</p>			
<b>Use and Storage of Toxic Substances</b> <i>658E.c.2.K</i>			<p>All toxic substances are used as recommended by the manufacturer and stored in the original labeled containers.</p> <ul style="list-style-type: none"> <li>a) All toxic substances are inaccessible to children. All hazardous products like bleach, bug spray, drain cleaners, ammonia, floor wax, furniture polish and disinfectants must be stored in a cabinet that has been fitted with a child safety lock.</li> <li>b) The telephone number for the poison center is posted in a location where it is readily available in emergency situations. <i>CFOC-5.2.9.1</i></li> </ul>			
<b>Safety of Equipment, Materials and Furnishings</b> <i>658E.c.2.K</i>			<p>Equipment, materials, furnishings, and play areas must be sturdy, safe, in good repair and meet the recommendations of the Consumer Product Safety Commission (CPSC). Ensure that environment is free of:</p> <ul style="list-style-type: none"> <li>a) Openings that could entrap a child’s head or limbs;</li> <li>b) Broken windows and discard any shards of glass..</li> <li>c) Elevated surfaces that are inadequately guarded;</li> <li>d) Climbable unsafe equipment;</li> <li>e) Mismatched size and design of equipment for the intended users;</li> <li>f) Clutter;</li> <li>g) Tripping hazards;</li> <li>h) Ripped carpet;</li> <li>i) Components that can pinch, shear, or crush body tissues;</li> <li>j) Sharp points or corners;</li> <li>k) Splinters;</li> <li>l) Protruding nails, bolts, or other parts that could entangle clothing or snag skin;</li> <li>m) Loose, rusty parts;</li> <li>n) Strangulation hazards (e.g., straps, strings, etc.)</li> <li>o) Plastic bags, matches, candles, and lighters that are accessible to children.</li> <li>p) Peeling paint on walls and furniture and/or paint that contains lead or other hazardous materials.</li> </ul> <p><i>CFOC- 5.2.9.5</i></p>
